
We're here with some new polling from our team on Trump favorability on immigration and the illegal detention of Kilmar Abrego García in a foreign prison.

The data suggests that conversation around Garcia's deportation is complex. Though voters are concerned about Garcia's case, our research indicates it is not currently the most potent issue to lower Trump's standing overall and among swing voters.

However, clip testing shows that when talking about the case and Trump's immigration actions more broadly, some approaches do work better than others such as focusing on why Trump's deportations may impact all Americans and highlighting specific examples of due process violations.

These findings are based on 25,588 responses across 3 surveys, collected via web panel April 16-22:

→ Immigration remains a strong point for Trump, with immigration approval both higher and less eroded than overall job approval, approval on the economy, and approval on cost of living:



→ Awareness of Kilmar Abrego García's case is lower than other recent news with 49% reporting they are at least somewhat aware (vs. 82% for tariff announcement). A 54% majority is concerned about Garcia's deportation:

→ Even for Trump voters, immigration is seen as a secondary priority for voters than lowering costs. 70% of swing voters would prefer to see Trump prioritize lowering everyday costs:

→ Yet similarly, 62% of voters say that prioritizing the cost of living should also be a bigger priority for Democrats compared to looking out for those who have had Constitutional rights violated:

→ One complicating factor when communicating about the details of Kilmar Abrego García's case is that voters are split on what groups of people are entitled to due process protections. While 34% of voters (including 59% of Harris voters) believe that everyone in the US regardless of legal status should have access to legal representation and court proceedings, 32% of voters overall (including 53% of Trump voters) say "only US citizens and legal residents."

Additionally, our team tested a number of recent clips of press interviews and DTCs of Elected Democrats: most performed below average (under the 50th percentile) at persuading voters to disapprove of Donald Trump. That said, videos that were more successful focused on how Trump's deportations might impact all Americans and highlighted specific examples of due process violations:

- Senator Murphy's clip (73rd percentile) lays out each step of Garcia's case then says "And why should this matter to you? Because if the President has the power to jail and prison, to deport anyone, even if they have a legal right to be here as a citizen or through protected status given by the courts, then none of us are safe."
- Rep Garcia's clip (63rd percentile) mentions how six students "have no idea why their actual student visas were actually revoked. No clue. Homeland Security won't tell them."
