

From May 14-18, we tested 65 unique Republican and Democratic messages on the current Republican reconciliation tax proposal. These messages were tested via web panel with 15,044 respondents and are ranked as relative to more than 500+ messages we have tested since Trump's 2.0 Inauguration Day.

**The most persuasive Democratic messages tied Republicans' tax plan to other direct harms, like increased grocery bills and health care costs:** In multiple top-performing messages, we saw resonance with those that linked the reconciliation plan to tariffs, benefit cuts, and rising costs of living as a "double whammy on families" like in these messages:

- **96th percentile:** "...Trump's tariffs already mean higher prices on basics like groceries and clothes. And now, his tax plan will make healthcare and groceries more expensive for Americans by slashing funding for Medicaid and food assistance to finance more tax breaks for the very rich and big corporations. It is a one-two punch that will make life worse for millions of Americans."
- **90th percentile:** *"...Trump's proposed tax bill makes life less affordable for working families when costs are already too high. Trump's tax plan will make healthcare and groceries more expensive for millions of Americans..."*

**The least persuasive Democratic messages focused on abstract, extreme language like calling the Trump Administration the "MAGA regime":** The least effective message out of those tested in this round called the reconciliation proposal "MAGA regime's Murder Budget" that "would take away our freedom to care for our families and have them come home safely."

- **11th percentile:** *"...the MAGA regime's Murder Budget would take away our freedom to care for our families and have them come home safely. We need Democratic leaders who prioritize healthcare, community safety, and family security, instead of putting essential services on the chopping block to fund tax cuts for the wealthy."*

For Republican messaging, **Republican attacks around Medicaid work requirements were persuasive to voters**, like Republican messaging that highlighted how the Republican plan would "kick millions of illegal aliens off of Medicaid to protect it for those who are the ones in real need." **To combat Republican attacks on Medicaid work requirements, we suggest using this effective message about how Medicaid cuts stretch American budgets further:**

- **89th percentile:** *"...Trump's plan to cut Medicaid would be a triple whammy on household budgets. First, people who lose Medicaid will flood ERs with untreated illnesses, driving up wait times and costs. Then, those with insurance will see co-pays spike as insurers pass increased costs onto consumers. And finally, nursing homes will jack up prices for increased costs – each step piling hidden surcharges onto premiums, deductibles, and long-term-care bills for regular Americans."*

Percentile ranking is relative to 500 other messages tested since Inauguration Day tested on a variety of topics, like inflation, abortion, the economy, and more. The higher the percentile, the more effective that talking point is at driving down Trump's disapproval. **We recommend utilizing above-average talking points, i.e. those above the 50th percentile.**
